Item No. 5 18th November, 2015.	<p>In pursuance of our order dtd. 08.10.2015 for constitution of the committee for inspecting the hospitals and other health facilities having authorisation under the Bio Medical Waste Rules, 1998 consisting of retired District Judges, representative of the District Chief Medical and Health Officer as well as representative of the R.O., M.P.Pollution Control Board, we have received consents from the following in respect of their respective cities (1) Ms. Renu Sharma, Rtd. District Judge, Bhopal (2) Ms. Meena Bhatt, Rtd. District Judge, Jabalpur (3) Mr. R.P. Verma, Rtd. District Judge, Indore (4) Mr. R.N. Patel, Rtd. District Judge, Jabalpur</p> <p>A copy of their consent letter be sent to the R.O, MPPCB at the respective destinations. The R.O., MPPCB concerned would depute officer from the Pollution Control Board regional office, while the Chief Medical & Health Officer of the District shall depute one officer from the office of the CM&HO. The officer from the Pollution Control Board shall co-ordinate with the respective Rtd. District Judges for carrying out the inspection and will provide all necessary logistics including transportation etc. It would be the responsibility of the CM&HO to apprise the Rtd. Judicial Officer</p>

about the various requirement under the BMW Rules, 1998 and the points to be noted while carrying out the inspection of the facilities and the hospitals which have been granted authorisation.

We have so far not received any consent from any Rtd. Judicial Officer from Gwalior. Registrar is directed to get the consent of Rtd. District Judge, Gwalior for the aforesaid purpose by sending a reminder. The first inspection shall be carried out within the month of December and report be submitted before this Tribunal by the first week of January, 2016. In the meanwhile, the R.O.,MPPCB shall also suggest the names of retired academician particularly in the rank of associate professors and professors in Environmental Science who may be included in the aforesaid monitoring committee. Apart from visiting the hospitals and health facilities the monitoring committee shall also visit the Bio-Medical Waste disposal site authorised for the said purpose.

The matter be listed for further direction as may be necessary on **12th January, 2016.**
